New Treatment Technology at Budincich Chiropractic Clinic

At the Parker Chiropractic Resource Foundation's Annual Convention in Las Vegas, Nevada, in January 2014, Dr. Budincich purchased some new equipment. This new technology equipment includes an ArthroStim® and a VibraCussor®. These two devices are made by the same company and are part of a chiropractic treatment called "impulse technique," or Creed Technique.

The ArthroStim® instrument is an adjusting percussive device with oscillations of between one

and 15 pulses per second for high speed adjustments with low force for certain conditions resistant to



regular hands-on adjustments. The instrument can be set with a variety of tips, from prong tips to single tips, in order to adjust specific vertebral segments and joints.

The second instrument, the VibraCussor® is a variable speed, high-performing soft tissue

mobilizer with which we are getting excellent results for tennis elbow

Dr. Budincich's Mission Teams Very Active in 2013

The year 2013 was very busy for Dr. Budincich's "MANOS CON ALAS" nonprofit organization and mission teams.

The first quarter of the year was spent in final preparation of the mobile dental trailer ("MDU") which was hauled down to Baja California in the first week of April 2013, just one week prior to its inaugural use. The 23-foot trailer was donated by "Pradit," prior owner of "Baldwin's Baked Potatoes" of Monrovia, California. The MDU was given a final installation of a 6500-watt ultra quiet ONAN RV generator. The two donated dental chairs and operatories were given final testing and wiring, and

the unit was hauled down by Dr. Budincich personally during April 2013. After being parked in our Baja Ensenada lot, the unit was used the very next weekend by our fly-in mission team at Casa Del Pastor in its abused women and children shelter at San Vicente, Baja California. For its inaugural use, two dentists, Dr. Gary Demerjian and Dr. Mark DeLeon, served 50 patients that day! This was along with many dozens of chiropractic services and dozens of free eyewear.

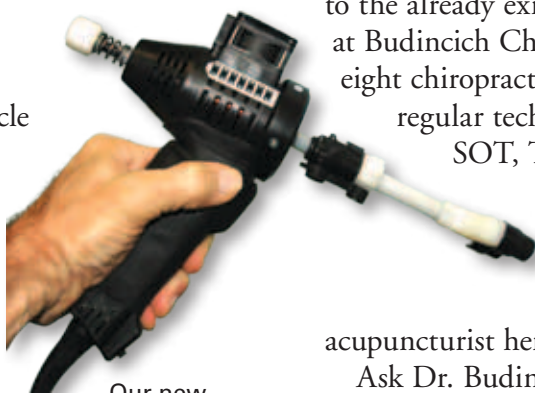
After our mission vehicles were vandalized in our parking lot south of Ensenada, the owner of the lot asked us to move our

Our regular techniques include Diversified, Activator, SOT, Thompson, Gonstead, Cox, Leander, and Deep Tissue Therapy. In addition to these chiropractic techniques, of course, we have been using deep tissue massage and we have an acupuncturist here, Dr. Polin Togi.

vehicles to another location. Dr. Budincich was forced to relocate the dental trailer and two of the mission vehicles (a 1990 Dodge Van 350 and a 1992 Chevrolet Suburban 2500) to the Rosarito Beach area where he had befriended some of the members of Flying Samaritans Rosarito Beach Chapter. As you may recall, Dr. Budincich has been a member of the Flying Samaritans since 1982 and he joined flying teams off and on ever since then. This Rosarito Beach Chapter Flying Samaritans have never had a dental team come down to accompany their medical doctors and the optician on any past trip in the past, so our initial clinic there in Ciudad Constitución enabled us to see 38 dental patients, dispense over 75 pairs of prescription eyewear, and provide many chiropractic treatments. This clinic took place on August 23, 2013.

Our next clinic was held on November 13, 2013, at the Calvary Chapel Rosarito Beach overseen by Pastor Mike Vincent. This was the largest clinic that Calvary Chapel had ever had when our team arrived with only seven members. Our two dentists, one chiropractor, and two lay opticians, along with translators, treated 55 dental patients, dispensed approximately 175 pairs of prescription eye glasses, and delivered 125 chiropractic adjustments. Hundreds were served with our small team of seven who flew in two aircraft.

At the November clinic, we learned of an abused and abandoned senior center in southern Tijuana. This center, called "El Refugio," housed 130 senior citizens

between the ages of 65 and 103 years old, seven to eight to a room. So we embarked upon serving them with the help of the Rosarito Beach Rotary Club, the Tijuana "Independencia" Rotary Club, and only two people from our U.S. mission team; Dr. Budincich and Carola Mendez. This event took place on January 4, 2014, just a few days after the holidays. This trip became difficult for many team members to attend because of visitations of relatives over the holidays still being here. Despite only two U.S. team members, we were able to give out 130 personal gift bags similar to those given by "Operation Christmas Child." These consisted of one-gallon zip-lock bags containing underwear, socks, a tooth brush, playing cards, pens and pencils, stationary, a handkerchief, a scarf, warm beanies, and other useful items. We also bought 80 pounds of meat, then prepared and helped serve 130 meals each at breakfast and lunch for these seniors. In addition, over 60 pairs of prescriptive eyewear were dispensed, particularly reading glasses, for these residents.

We are always looking for new team members with medical, dental or chiropractic background to join our mission teams, along with translators, pilots and general helpers.
